- Pre-bid meeting shall be held at Office of Rural Municipal Executive, Annapurna Rural Municipality, Myagdi at 2:00 PM on 2076/11/29 .The attendance in pre-bid meeting is optional but interested bidders are encouraged to attend to the pre-bid meeting.
- Sealed Hardcopy Bids must be submitted through Hand on or before 12:00 Noon on 2076/12/14. Bids received after this deadline will be 5. rejected. The copy of bid security, bid document fee voucher, company/firm registration, renewal, tax clearance certificate should be submitted at the time of bid submission.
- The bids will be opened at 2:00 pm on 2076/12/14 at the Office of Rural Municipal Executive, Annapurna Rural Municipality, Pokharebagar, 6. Myagdi in the presence of Bidders' representatives who choose to attend but attendance is not mandatory. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, which shall be valid for 30 days beyond the bid validity period.
- If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the 7. validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- Bidders are required to specify the total price of the bid in the letter of bid or the bid price in the summary of bill of quantities. Failure to specify 8. the total price of the bid in the letter of bid or in the summary of quantities shall be ground for declaring the bid non responsive.
- 9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
